Call to Order

Mr. Stabile opened the August 27, 2009 Regular Meeting of the Mansfield Township Board of Education at 7:31 p.m. with the following statement:

determined that the motor was burned out. We anticipate that the cost to replace the motor is \$500 plus labor.

6. **Electric System:** A recent brown-out caused the loss of two computers and some other pieces of equipment.

8. **H1N1:** Mr. Melitsky and Dr. Clancy attended a workshop on August 25, 2009. The primary purpose of the workshop was to get everyone all around the state on the same page. Mr. Melitsky told us that he feels good about where we are in terms of what schools are supposed to be doing to prepare appropriately. We are already doing what was being covered at the meeting.

The County Superintendent will be holding a meeting with all county school administration. He will be the "county public relations" person.

A meeting will be held with Dr. Clancy and Ms. Colleen Hurley to finish up the H1N1 Plan.

Ms. Colleen Hurley and Dr. Clancy will have a table at Back to School Night with all the available up-to-date information on the topic. A copy of the plan will be on the school's website. It was suggested that a presentation be made to the entire community as a public service.

The moderator at the conference suggested that teachers have three weeks of lessons prepared. Mr. Melitsky felt this was overkill.

Immunizations were discussed with regard to the procedures. Religious and voluntary exemptions will still be recognized.

The CDC and the State Department of Education is advocating not closing schools.

Ms. Roszkowski reported that when State Aid figures were distributed, there was a new category included in the report. When officials were questioned about the new category, School Business Administrators were assured that it was “just” a new category and had no meaning nor would it be something that would eventually be taken away. That assurance was given in the March, 2009, timeframe.

ARRA Funds

On or about June 28, 2009, we were told that the new category was in fact ARRA funding and that it would disappear in two years.

There are many obligations on part of the district for the accounting of these funds and recordkeeping. Business administrators are currently being trained in the additional recordkeeping and report filings mandated by receipt of ARRA funds. We are obligated to report how many jobs

are being saved by receipt of these funds on a quarterly basis. The district will have to keep notes on whose jobs were saved with these funds in the event State and/or Federal auditors are sent to inspect our books.

New accounts tracking these funds will be set up and will come before the Board for approval.
